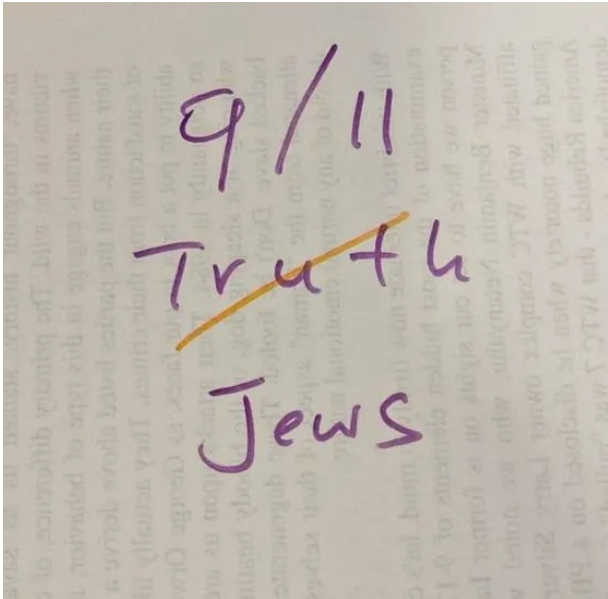


9/11 Coincidence Theory

An incomplete list of “completely circumstantial” Jewish connections with 9/11

I was at the Pudong Shangri-La Hotel on the evening of Sept 11, 2001(Beijing Time) for a dinner with a grad school professor.

When we walked into the hotel bar for a drink, there was a crowd gathered around a TV screen watching a live CNN footage of a burning WTC North Tower.

Then there was another explosion in the other tower with a massive fireball bursting out of the windows.

I was stunned and thought it couldn't be real. What happened must be a high drama, mistakenly broadcast as live news.

I was glued at the hotel TV for a couple of hours and went home just to continue the live coverage of that day's events from my satellite dish – yes, satellite dishes were still used in those days.

Over the years, the shock wore off but there was always an eerie feeling what happened wasn't real.

It was only in 2016 when I first stumbled on the internet hit film ***Loose Change*** that ignited an interest to find out more about the event.

It was a rabbit hole.

9/11 had even more layers of mysteries than the JFK assassination, which I read up over the years out of curiosity since the 1992 Oliver Stone movie.

After reading dozens of books and browsing many more websites, I came to form a view on the event.

I started to write this essay a year ago when Tucker Carlson's 9/11 series in 2025 generated renewed interest in the catastrophic event.

But the Carlson revisit was obscured quickly by the 9/10 killing of Charlie Kurk, by a "lone gunman" in the same fashion as Lee Oswald and Sirhan Sirhan.

All too convenient.

I am dusting off the article for the 25th anniversary of the event – a *Turning Point* for USA (Kirk association intended). For those interested, I wrote a piece on Charlie Kirk on Substack which is in the archive of posts.

Few thinking people doubt that the mountain of evidence suggests a radically different 9/11 truth from the official narrative.

While a US government coverup is obvious, there are lots of theories about what really happened and, most importantly, who was responsible.

These theories are derided and dismissed by mainstream media and the regime as "***Conspiracy Theories***".

To avoid the stink, I hereby offer a "***Coincidence Theory***" and an investigative angle uncomfortable to some.

My theory posits that there are numerous "*completely circumstantial and innocent*" (wink wink) connections between the 9/11 terror attack and individuals and organizations of the Jewish extraction.

Not just Israeli Jews but American Jews. In some cases, dual citizens.

I believe the voluminous connections prove valid basis for questions. Perhaps even the basis for a "*Coincidence Theory*".

For those statistically minded, it would be an interesting exercise to calculate the odds of so many "*coincidences*" happening around one event.

The first rule in any criminal investigation is *Cui Bono*, who stands to benefit from the crime.

Who benefited the most from the 9/11 attacks?

The answer was given by the genocider Benjamin Netanyahu, who explicitly stated the 9/11 attacks were "good" for Israel.

Not once, but on two separate occasions.

The New York Times reported that on the very day of the attacks, Netanyahu was asked by a reporter what the attack meant for Israel.

He replied: **“It’s very good.”** He immediately corrected himself, adding, **“Well, not very good, but it will generate immediate sympathy.”**

Seven years later, in April 2008, Netanyahu reiterated the point during a speech at Bar-Ilan University.

The Israeli newspaper *Ma’ariv* reported his exact words: **“We are benefiting from one thing, and that is the attack on the Twin Towers and Pentagon, and the American struggle in Iraq.”**

As Israel clearly benefited the most from the attack, would it be too much to put the state of Israel on the suspect list?

The Jewish nation has certainly shown the world that it is the most prolific and ruthless state practitioner of false flag terrorism and targeted killings.

It is the original state actor that invented modern false flag terrorism with the King David Hotel bombing, the Lavon Affair, and the attack on USS Liberty.

When it comes to 9/11, despite the absence of a “smoking gun” of Israeli culpability, a large body of circumstantial evidence – public to all – points at the direction.

I have compiled an incomplete list of Jewish connections with 9/11 based on my readings.

For brevity, I have purposely skipped any Zionist goyim who were complicit but not Jewish. That list would be a mile long.

The list is organized into several buckets – *the deciders, the planners, the muscle, the enablers, the cleanup crew, and the coverup artists*. I also include a few strange *odds and bits*.

I want to call out that some connections, suspicious as they may be, could be innocent of direct involvement in 9/11.

They could simply have served as “inspirations” or “gate keepers”.

The Deciders

Ariel Sharon (Jew). Sitting Israeli Prime Minister during 9/11. Globally renowned war criminal as “the Butcher of Tel Aviv”.

Nicknamed “The Bulldozer” and “The Butcher” for his ruthlessness, Sharon spanned decades of Israel’s foundational military aggression in the region.

Before entering politics, Sharon was a “celebrated” commander in the IDF, where he was known for high civilian casualty scorched earth tactics such as the 1953 Qibya massacre.

In the 1973 Yom Kippur War, he invaded the Sinai. Under Menachem Begin, Sharon orchestrated the 1982 invasion of Lebanon.

During the invasion, Christian Phalangist militias under his command entered the Sabra and Shatila refugee camps in Beirut and massacred hundreds of Palestinian civilians.

In September 2000, Sharon made a highly publicized visit to the Temple Mount (Al-Aqsa Mosque compound) in Jerusalem.

Flanked by hundreds of riot police, the visit was viewed as a deliberate provocation by Palestinians and served as a major catalyst for the Second Intifada.

This likely served as the immediate ruse for the 9/11 false flag terror attack, whose goal was to drag the US into endless Middle Eastern wars against Israel’s enemies.

After 9/11, the Bush administration fully integrated Israel’s conflict with the Palestinians into the global War on Terror.

Sharon moved swiftly to frame the Palestinian suicide bombings in Israel as identical in nature to the al-Qaeda attacks against America.

He argued that Israel and the US were fighting the exact same enemy: radical Islamist terrorism.

Sharon convinced Bush that Palestinian Authority Chairman Yasser Arafat was an irredeemable sponsor of terror rather than a viable partner for peace with his famous words “Arafat is Bin Laden”.

The peak of the Bush-Sharon relationship came on April 14, 2004, during a summit at the White House.

Bush handed Sharon an official *Letter of Commitment* that fundamentally altered long-standing US foreign policy.

Bush explicitly acknowledged that given “new realities on the ground,” it was unrealistic to expect Israel to return completely to the pre-1967 borders, effectively recognizing Israel’s illegal territory expansions.

Bush stated that Palestinian refugees should be resettled in a future Palestinian state, completely rejecting the right of return into their sovereign territory under Israeli occupation.

This diplomatic concession was considered an unprecedented victory for Sharon, something impossible without the 9/11 pretext.

In a show of cosmic justice, Sharon suffered a hemorrhagic stroke in 2006 while in office.

He fell into a persistent vegetative state and never regained consciousness until the Jew mass murderer died as a vegetable 8 years later.

Ehud Barak (Jew). Israeli prime minister between 1999 and March 2001, immediately before Ariel Sharon. Back in news these days as best buddy with Jeffrey Epstein for 15 years.

Barak just happened to be on air at BBC World during the 9/11 attack and one hour after the explosion at the North Tower, Barak pointed the finger at Bin Laden and concluded “it’s time to launch an operational, complete war against terror”.

Benjamin Netanyahu (Jew). The terrorist who coined the term “war on terrorism” in the 1980s to promote the idea Israel’s enemies are terrorists and to involve the US to fight its enemies.

Son of Ben Zion Mileikowsky of Warsaw, Poland, who was a senior aide to Vlad Jabotinsky, the founder of the terrorist organization *Irgun*, which in turn is the political parent of the Likud party.

Never one to miss a party, Netanyahu “happened” to be in London on the 7/7 terrorist attack in 2005 by “Islamic terrorists” on London public transport.

He was alerted beforehand of a possible terrorist attack that day by Mossad, according to news reports.

Israeli company Comverse/Verint was given the contract to install “networked video systems” in the London underground a year prior to the 7/7 attacks, which “happened” to fail on that day.

The Planners

PNAC. Project for New American Century. The neocon organization behind the *Rebuilding America’s Defenses* report, published in 2000, calling for a “catastrophic and catalyzing event – like a new Pearl Harbor”.

The concept of “neocon” is synonymous with “Zionist” in its ideology and in the fact a majority of the best-known neocons are Jews by ethnicity.

Michael Ledeen (Jew). Super hawk neocon strategist, advocate of Jewish supremacy, and a great example of the PNAC ideology.

Ledeen served as a special adviser to the Secretary of State and a consultant to the National Security Council and Department of Defense during the Reagan administration.

He was most famous for being a key intermediary who helped instigate the *Iran-Contra* affair in the 1980s by brokering secret meetings between US officials, Israeli arms dealers, and Iranian representatives to trade weapons for hostages.

Formally working as a think tank scholar at the American Enterprise Institute (AEI), he served as an intellectual architect for the post-9/11 “War on Terror”.

Immediately following the attacks, he was brought in as a consultant for the Office of Undersecretary of Defense for Policy under Douglas Feith (Jew).

He became widely known for the “Ledeen Doctrine”, advocating aggressive, sweeping regime changes across the Middle East.

He explicitly argued that *“Every ten years or so, the United States needs to pick up some small crappy little country and throw it against the wall, just to show the world we mean business.”*

In the wake of 9/11, Ledeen worked closely with Pentagon officials to argue that US military intervention should expand beyond Afghanistan to forcefully depose regimes in Iraq and Iran.

While other PNAC members concentrated heavily on toppling Saddam Hussein in Iraq, Ledeen’s personal obsession was regime change in Iran.

Ledeen served on the board of the Jewish Institute for National Security Affairs (JINSA), an influential Jewish lobby that shares a massive overlap in goals and personnel with PNAC, counting figures like Dick Cheney and Richard Perle among its members.

The Muscle

5 “Dancing Israelis”. Sivan and Paul kurzberg, Yaron Shmuel, etc. Mossad undercover agents as “movers” at a Jew-owned business Urban Moving Systems.

Described in news reports as “Middle Eastern looking men” and seen by witnesses celebrating and filming the destruction of the trade centers with the burning towers behind as they flicked cigarette lighters and laughed and danced.

After being released from FBI custody back to Israel, three of them admitted on Israeli TV, in Hebrew, that they were there to “document the event”.

Urban Moving Systems. Mossad front company in New Jersey. Employer of the 5 “dancing Israelis” and own by Dominik Suter (Jew), who fled to Israel after 9/11.

Israeli “art students” spy ring. More than 140 Jews were arrested under suspicion of espionage around 9/11.

Many of these fake art students lived around Hollywood, Florida, where 15 of the 19 alleged Arab hijackers has grouped.

Majority of these Israeli spies, under question, stated they served in military intelligence, electronic signal intercept, or explosive ordinance units.

One such “art student”, former Israeli military intelligence officer, Hanan Serfaty, rented an apartment at 4220 Sheridan Street when Mohammed Atta was staying at 3389 Sheridan Street.

The Enablers

“Lucky” Larry Silverstein (Jew). Owner of WTC 7 and lease holder of WTC1 and 2, secured 6 weeks before 911. All three towers fell on Sept 11.

“Lucky” Larry was the winner of \$4.5 billion insurance payout for him \$15 million lease downpayment of the twin towers.

He was the lucky “survivor” of the attack due to a last-minute dermatologist appointment arranged by his wife. Ordinarily Lucky Larry starts his way with breakfast at the *Window on the World* restaurant on top of the North Tower.

Lucky Larry’s children also closely missed death because they were “running late” for their meetings that morning.

Silverstein was the president of the United Jewish Appeal. Netanyahu called him every Sunday without fail, according to reports.

He was also a friend of Ariel “the Butcher” Sharon, Israeli Prime Minister on 9/11.

Silverstein’s partner to win the privatization bid of the twin tower was Frank Lowy (Jew), who is the owner of Westfield, a mall operator who leased the retail space at the WTC complex.

Lewis Eisenberg (Jew). Chairman of Port Authority of New York and New Jersey, owner of the WTC complex.

Eisenberg was a member of the United Jewish Appeal Federation and former vice president of AIPAC, the Jewish lobby.

Eisenberg rewarded the WTC lease, as part of a privatization plan (more on this later), to Silverstein and Lowy despite the fact they submitted the lowest bid.

Ronald Lauder (Jew). Heir of the Estee Lauder cosmetics fortune. Chairman of the New York Privatization board who helped with Silverstein's acquisition of WTC from PANYNJ.

According to Wikipedia, Lauder is involved with the [Conference of Presidents of Major American Jewish Organizations](#), the [Jewish National Fund](#), the [World Jewish Congress](#), the [American Jewish Joint Distribution Committee](#), the [Anti-Defamation League](#), the [Jewish Theological Seminary](#), [Rabbinical College of America](#), and the [Abraham Fund](#).

He was the envoy for Netanyahu in land-for-peace negotiations with Syria in 1998.

Barbara Olson (Jew). Born Barbara Kay Bracher, educated at Yeshiva University, CNN reporter and wife of Ted Olsen, Solicitor General.

She was a "victim" allegedly on board flight AA77, the one that flew into the Pentagon.

While on the flight, she made two calls from her mobile phone to Ted Olsen and supplied the fodder for the myth of "box cutter" wielding Arab terrorists.

Of course, we all know how easy it was back in 2001 to make mobile phone calls from a jetliner at cruising altitude.

Too bad, that technology is lost just like the moon-landing tech is lost due to some mysterious technological regression. I still cannot make calls on my 5G smartphone from a flight.

Indeed, multiple mobile calls were reportedly made from various flights involved in 9/11. Some lasted over 40 minutes with sound quality of a landline.

Another interesting coincidence is that Ted Olsen was the lead attorney representing George W Bush in the legal battle over the 2000 Florida recount which secured his marginal victory over Al Gore.

Maurice Greenberg (Jew) and Jeffrey Greenberg (Jew). Father and son, CEOs of AIG and Marsh McLennan respectively.

AA11 directly flew into the offices of Marsh McLennan in the North Tower on the morning of 9/11. Flight AA11 hit the North Tower between 92nd and 98th floor and Marsh occupied floors 93rd to 100th.

Luckily, the father and son were not in.

Even more fortunate, as long time insurers of the twin towers, they took the precaution of having the contract reinsured by Swiss Re and Munich Re, on July 24, 2001.

AIG was also the owner of Kroll Associates, the firm in charge of WTC security.

One board member of Marsh McLennan, Paul Bremer, went on NBC to name Bin Laden as the prime suspect less than two hours after the first attack.

Bremer later stole \$8 billion aid money as the provost governor of Iraq for the US invasion.

Jules and Jeremy Kroll (Jews). Founders of Kroll Associates. Responsible for WTC security and have complete access to the complex.

The towers went through several power blackouts during two weekends before the attack. All electronic access and surveillance camera systems were shut down.

Bomb-sniffing dogs, a long-time security feature of the towers after the 1993 WTC bombing, were called off 3 weeks before 9/11.

Alvin Bernard “Buzzy” Krongard (Jew). Appointed as executive director of CIA by George Tenet, the CIA Director, in March 2001. It is the No. 3 job in CIA.

Before CIA, he was the CEO of BT Alex Brown under Deutsche Bank.

Alex Brown was the investment bank where most of the short selling (put options) of United and American Airlines stocks took place right before 911.

Krongard’s wife, Sheryl Gordon, was a long-time employee of Rothschild Asset Management.

Rabbi Dov Zakheim (Jew). Pentagon Comptroller and CFO on 911.

Donald Rumsfeld, the secretary of defense, announced “we cannot track \$2.3 trillion in transactions” on Sept 10, 2001, the day before 9/11.

It was Zakheim’s responsibility to investigate the missing trillions.

Unfortunately, many budget analysts involved with the forensic accounting of the missing funds were killed when AA77 struck their Pentagon offices. Financial records were destroyed.

Prior to Pentagon, Zakheim was the CEO of System Planning Corporation (SPC), a defense contractor that specialized in electronic warfare technologies and aircraft remote control systems.

SPC manufactured flight termination technology (FTT).

Airliners fitted with specialized FTT could be “home run” remote-controlled to fly into pre-programmed targets.

Such technology effectively locks the pilots out of cockpit control via autopilot overrides.

Odigo – Israeli instant messaging service provider owned by Micha Macover (Jew).

Odigo issued warnings to its employees and Israeli nationals using its service to avoid the WTC complex two hours prior to the attack.

Burns and Roe Securacom. Owned by Marvin Burns (Jew), Securacom had security contracts with the WTC, Dulles Int'l Airport, and United Airlines, which were all connected to 911. Clearly, Securacom “failed” in its assigned duties.

Marvin Bush, W's brother, sat on its board of directors.

ICTS (International Consultants on Targeted Security). Israeli airport passenger screening and security firm. Owned by Ezra Harel (Jew) and Menachem Atzman (Jew).

Its subsidiary, Huntleigh USA, was responsible for security at Boston Logan and Newark airports, both departure airports involved in 911.

ICTS was also responsible for security at the Paris and Amsterdam airports where the “shoe bomber” and “underwear bomber” boarded flights allegedly to attack the US.

The Cleanup Crew

Michael Chertoff (Jew). Assistant Attorney General and head of Criminal Division of Justice Department. Responsible for the investigation of 911 including overseeing FBI's work.

He later became the second Director of the Department of Homeland Security.

Chertoff released over 100 members of the Israeli “art students” spy ring and the “Dancing Israelis” arrested during 9/11 from custody. These Israelis were sent home for “visa violations”.

Chertoff compiled the list of “19 Arab hijackers” within 36 hours of the attack despite their names were not on any flight manifests.

He co-authored the Patriot Act.

Richard Sheirer (Jew). Director of Mayor Rudolph Giuliani's Office of Emergency Management from during 9/11.

Known as “Ground Zero's Jewish Knight” after being named an honorary Jewish Knight by the New York Board of Rabbis for his work at Ground Zero.

Sheirer was given complete authority over the WTC cleanup effort and directly involved in the destruction of key evidence at the crime site, especially the steel structures.

Michael Bloomberg (Jew). Mayor of New York City following 9/11.

Famously tried minimizing this criminal destruction of evidence by saying, “Just looking at a piece of steel doesn’t tell you anything.”

Bloomberg threatened NYPD and NYFD employees with prosecution and loss of job and pensions if they spoke out about what they experienced that day such as explosions in the towers, molten iron in the rubble,

Metals Management of Newark and Hugo Neu Schnitzer of New York. Owned by Alan Ratner (Jew) and Hugo Neu (Jew).

Responsible for disposal of WTC debris, including the destroyed steel structure.

Prevented any study of potential explosives used to demolish the buildings.

Its trading arm was called Hugo Neu Schnitzer Global Trade and headed by two Israeli Jews named Nathan Fruchter and Jehuda Saar.

Before Hugo Neu, Fruchter and Saar both worked for the criminal and Mossad asset Marc Rich (Jew) at Glencore International.

The 250,000 tons steel structures recovered from the WTC towers were sold as scrap before they could be tested for explosive residue.

PowerLoc Technologies. Trucking company owned by Israeli Yoram Shalmon.

Hired to haul away the rubble and debris from the WTC to Fresh Kill landfill and the two Jewish-owned scrap companies – Metals Management and Hugo Neu.

Famously known for putting GPS trackers on the haul trucks to ensure no deviation from approved routes for truckers.

Alan Dershowitz (Jew). Legal vulture, Jeffrey Epstein’s lawyer, and defender of Israel on TV and in court.

Dershowitz personally arranged to set the 5 dancing Israelis free, according to Counterpunch.

Kenneth Feinberg (Jew). Responsible for the 9/11 Victim Compensation Fund, which was organized specifically to prevent victims’ families from speaking out about the attacks or engaging in any future lawsuits against the airlines, government, or security agencies involved on 9/11.

Once a grieving family accepted the fund’s payout money, they were prevented from ever speaking publicly about the events or pursuing justice through the courts.

His wife, Diane Feinberg, is an executive member of the United Jewish Appeal – the organization to which Larry Silverstein and Lewis Eisenberg both belonged.

Alvin K. Hellerstein (Jew). Judge for the US District Court for the Southern District of New

York. The only judge presiding over all the 9/11 tort litigation.

Hellerstein so delayed the process and set roadblocks at every turn that finally in 2011, ten years after the attacks, the last family still holding out hope for getting an open trial, the Bavis family of Boston, was forced to settle out of court.

The Coverup Artists

Philip Zelikow (Jew). Architect for the official coverup as Executive Director of the 9/11 Commission.

Zelikow is a dual Israeli-American citizen and close friend with Bush National Security Advisor Condi Rice and chief of staff Karl Rove.

He was put in charge to control the official narrative of the 9/11 Commission Report.

In December 1998, Philip Zelikow, whose PhD dissertation was on *“The Creation and Maintenance of the Public Myth,”* co-authored a report for Foreign Affairs titled *Catastrophic Terrorism: Tackling the New Danger* with Ashton Carter (Jew) and John Deutch (Jew).

The report’s first section, ‘Imagining the Transforming Event,’ warned that catastrophic terrorism is coming to America, and details how America should respond, as well as how the country could change as a result.

Philip Zelikow presciently wrote that a catastrophic terror attack on America would be a “transforming event,” a “watershed event in American history” that would, “like Pearl Harbor... divide our past and future into a before and after.”

The “after” would feature “draconian measures, scaling back civil liberties, allowing wider surveillance of citizens, detention of suspects, and use of deadly force.”

Zelikow’s foresights were proven prescient.

Both Ashton Carter (Sec. of Defense under Obama) and John Deutch (Director of the CIA 1995-96) were senior partners of Global Technology Partners, an exclusive affiliate of Rothschild North America, when ‘Catastrophic Terrorism’ was written.

National Institute of Standard and Technology (NIST). Headed by William Jeffrey (original name Jaffe, Russian Jew).

Responsible for technical cover up of the destruction of the WTC towers.

NIST released its *“Final Report of the World Trade Center Disaster Investigations”* in September of 2005 and was widely ridiculed for its pseudoscience.

It built a computer model to explain the collapse of WTC 7 but refused to release the parameters for peer view due to “security concerns”.

The Inspirations

Isser Harel (Jew). Israeli spymaster and uber terrorist (director of the Hagana terrorist organization), founder of both Shin Bet and Mossad (Israel's internal and external intelligence agencies).

Harel predicted in an interview with Zionist Michael Evans on Sept 23, 1980, that New York City, especially the WTC towers, would be the target of a "bombing" sometime in the future.

In his article "*Jimmy Carter: radical Islam's ally*", Evans wrote "my last question was would terrorism ever come to American".

Harel answered: "you have the power to fight it, but not the will. They have the will, but not the power. All of that will change in time. *Yes, I fear it will come to New York and your tallest building, which is a symbol of your fertility*".

This terrorist "prophet" correctly called out the WTC towers would be targeted as the phallic symbol of US power. Another Jewish prophet like Philip Zelikow.

Arnon Milchan (Jew). Hollywood billionaire producer and super Israeli spy.

Milchan openly admitted to working as a covert operative for LAKAM (the Bureau of Scientific Relations), a highly secretive Israeli intelligence agency tasked with stealing Western military technology.

Milchan was instrumental in stealing the materials from the US for Israel's nuclear weapon program.

Milchan also produced the *Medusa Touch*, a movie where a jumbo jet was flown into a London skyscraper.

He is a close friend with Rupert Murdoch, whose Fox TV aired an eerie pilot episode of a TV series called *Lone Gunmen* in which a jetliner was hijacked to be flown into the WTC.

The show was filmed in early 2000 and broadcast in March 2001.

The plot was about a covert government conspiracy where a rogue faction with the Pentagon hacked into a commercial airliner's flight controls to remotely steer the passenger plane into the World Trade Center.

The villains in the episode state that they want to stage a spectacular, terrifying attack and blame it on foreign terrorists to stimulate the domestic defense industry, spark a new global war, and secure massive corporate military contracts.

Feels like someone got his hand on the planning document.

Milchan was the producer of Oliver Stone's JFK movie in 1992, successfully redirecting

suspicion about JFK assassination to the military industrial complex and US deep state from inquiries about Israel's role.

JFK tried very hard to prevent the illicit Israeli nuclear weapon program by pressuring Ben Gurion, then Israeli prime minister.

After his assassination, LBJ turned a blind eye and dialed up US military support for Israel.

Milchan is also a good friend with Netanyahu and involved in the latter's corruption charges in Israel. He bribed Netanyahu and his wife with hundreds of thousands dollars worth of "gifts".

In return, Netanyahu helped him secure his long-term visa to the US from John Kerry, then secretary of state. The US State Department was under pressure to suspend Milchan's visa due to his publicly acknowledged role in dealing US nuclear weapon technology for Israel.

Odds and bits

Henry Kissinger (Jew). Floated as the candidate to lead the 9/11 Commission but rejected by families of victims due to his well-documented crimes against humanity and his conflict of interest in dealings with the Saudi royal family.

Howard Lutnick (Jew). Another "lucky" guy who failed to show up for work at his regular hours because "his wife asked him to drive his kid to school. Something he hadn't done for 5 years. Not so lucky for the 658 employees at Cantor Fitzgerald who perished during the attack. Cantor Fitzgerald is a Wall Street firm located in the North Tower where Lutnick was the CEO on 9/11.

Perhaps Chomsky and Zinn also “heard the Jewish music” when they saw what happened during and after 9/11 and decided to guide the public discourse towards the “blowback” direction.

After all, Chomsky turned out to be another Epstein pal.

ZIM Shipping. Owned by the state of Israel and another Jewish entity with “lucky breaks” on 9/11.

ZIM Shipping broke its lease contract and moved out of WTC 2 tower weeks before 911.

The CEO Shaul Cohen-Mintz told USA Today “like an act of God, we moved.”

9/11 Memorial and the new World Trade Center building. 911 Memorial was designed by Michael Arad, an Israeli Jew who served in the Golan Brigade commando unit and whose father, Moshe Arad, was the Israeli Ambassador to America.

The official story claims Arad submitted his name into a contest in 2003 to build the 9/11 memorial and he was selected out of 13,683 registrants from 94 countries.

The designer of the new WTC was a Polish Jew named Daniel Libeskind.

The symbolism is complete – 9/11 is a Jew job.
